The following snowmobiles are owned and operated by Mt. Meadows Store and Campground, LLC, Hill City, South Dakota.

The undersigned renter agrees to rent the snowmobiles described below hereinafter referred to as "Equipment". At the rates established by the lessor and to furnish the required deposit which will be refunded upon return of the Equipment in satisfactory condition. Renter is absolutely liable for all damages to the Equipment while it is in his or her possession and under his or her control. It's the responsibility of the renter to seek payment for damages done by some third party from the responsible party.

Renter agrees to abide by the following rules and recommendations:

1. The Equipment may be operated only on designated snowmobile areas.
2. Negotiate slopes and narrow trails with caution. Drive at a prudent speed.
3. Renter understands how to operate the throttle, brake and safety switches and will always check them before operating the snowmobile.
4. Note and follow the warnings on equipment.
5. Keep your feet on the running board. Do not allow any part of your body or clothing to come in contact with the track.
6. Don't let the engine idle for long periods of time.
7. Don't tailgate other snowmobiles, look and signal when stopping or turning.
8. Should this Equipment become unsafe immediately discontinue use and notify Mt Meadows Store and Campground so repairs can be made.
9. No one is to check the track system, under the hood, skis or any part of the snowmobile while it is running.
10. The equipment shall be operated in accordance with the snowmobile checklist.
11. Any person riding the snowmobile must wear a helmet during operation.
12. All equipment must be returned to Mt Meadows Store and Campground by 5pm. A penalty of \$50.00 every half-hour will be assessed after 5pm.

The undersigned renter, in further consideration of the lease of the equipment from the lesser, hereby agrees to indemnify lessor and hold him/her, his /her successors, and assigns harmless from any and all claims of bodily injury or property damage brought by persons other than by the renter resulting in any matter whatsoever from the operations or possession of the lease Equipment.

The undersigned renter, in further consideration to the lease of the Equipment, hereby waives any and all claims against lessor and hold him/her, his /her successors and assigns, harmless from any and all claims by his/her family, passengers, or any other persons the he/she might allow to ride on or operate the leased Equipment, for the bodily injury or property damage resulting in any manner whatsoever from operation or possession of the leased Equipment by the renter.

The term "lessor" shall apply to the officers, directors, members, and employees of the Mt. Meadows Store and Campground, L.L.C.

I have read and understood the above and agree to be bound by the terms thereof, and have received instruction from the Lessor on the safe operation of Equipment.

Renter agrees and acknowledges that in event of accidently his or her insurance shall be considered primary insurance and he or she shall be liable for any damages occurring as a result of said accident, and any obligations of Lessor hereunder shall be secondary. Furthermore, Renter specifically assigns to Lessor all rights under said policy, including, without limitation, personal injury and property damage coverage. In the event of accident, lessor is hereby authorized to negotiate any settlement for and on behalf of the Rented to the extent of the lessor's ability to any third party as a result of the used of the vehicle by their renter.

Perking or traffic violations are the Renter's responsibility. Vehicles resumed tro be embezzled if not returned when due by law.

Renter is subject to additional fee if equipment is not returned to above address.
